Bill is the past Chairperson of the Hillsborough County Domestic Violence Fatality Review Team and is the current Vice President of the National Institute of Crime Prevention.

Rod was previously the Crimes Against Persons supervisor, and was the Domestic Violence Coordinator for the Sheriff's Office for seven years. S. Department of Justice. He has received numerous awards such as the Florida Governors "Peace at Home Award". Rod is the Vice President of the National Institute of Crime Prevention.
